

ENTRY RULES

DOG HOUSE and KITTY CONDO

- 1. The house included on pages 2 and 3 can be altered as you desire. You may add paint, provide new windows, replace and extend the roof, create a base/ deck with water and food bowls, add light fixtures, solar panels, etc. If creating a kitty condo, you may provide a cat tree as part of the design.
- 2. The final product must have a floor, 3 walls minimum, a roof and must be waterproof.
- 3. All products must be safe for dogs and cats.
- 4. No real fur or materials derived from animals are permitted.
- 5. Items such as food bowls and play toys may be included as part of the design.
- 6. Exposed Dangers Pay special attention to exposed corners, sharp edges and unfinished materials. Fasten any decorative items securely.
- 7. There shall be no limit to the amount of work provided to change or alter the original house design.
- 8. New materials for each house entry shall be provided by the sponsors or by the team members.







TEAM SPONSORSHIP

Team sponsorships will be accepted in accordance with the following guidelines:

- 1. Each team shall have a maximum of five (5) team members and up to three (3) sponsors. Sponsors can be A&D representatives, product reps or contractors.
- 2. For each of the sponsors, there will be a cap of \$375.00 including material and dog house. The cost of the materials provided should be kept to a minimal so that the left over money will be a donation to GAIDP and our charity, Paw Project of GA.
- 3. Each team will be responsible for securing materials from the sponsors or purchasing materials as needed to finalize your design.
- 4. We accept all major credit cards through a Paypal invoice for entry fees.
